



First Dutch edition of "the most convincing, detailed and reliable account of the riches and new things of America" (Streeter), written by the Spanish Jesuit José de Acosta (1539/40-1600) and translated by Jan Huyghen van Linschoten from the original Spanish. The "West Indies" of the title still referred at this date to the New World as a whole, and the book concentrates on the Spanish possessions in Peru and Mexico, covering the Inca and Aztec people, customs, history, botany, zoology, mineral riches, trade, products, and much more. It was this book above all others that opened the eyes of the Dutch, the English and the rest of Europe to the extraordinary wealth Spain was reaping from its possessions in the New World, and it includes practical information such as sailing instructions, accounts of diseases, etc. With a 1645 owner's inscription, library stamps and the armorial bookplate of the Marchese of Bernezzo on the back of the title page. With some repairs in the first two quires, the title page rather worn and two leaves somewhat browned, but otherwise in good condition. The binding is scuffed and has cracks in the vellum at the front hinge, but is still good and structurally sound. The most influential early work on America, in its first Dutch edition.



Rare pamphlet in support of Antonio López de Santa Anna (1794–1876) after he had proclaimed his plan for a federal republic in San Luis Potosí on 5 June 1823, shortly after the emperor's abdication. The work is a legal and political defence of his actions, and is composed of official letters, legal opinions, and summaries of the proceedings. It presents arguments that Santa Anna's conduct was not only justified, but also aligned with the will of the Mexican people. Though his plan was initially divisive, Mexico was established as a federal republic a year later. The pamphlet is very rare, as we have not been able to find any other copies in sales records. It is of significant historical importance, however, as it offers a rare contemporary perspective on early Mexican federalism and on Santa Anna's rise as a pivotal figure in Mexican politics.

The work is very lightly browned and foxed, with 3 small wormholes throughout, affecting a few letters. Otherwise in good condition.

# Exceptionally rare decree, establishing the Second Regency of the Mexican Empire



Important, but unrecorded, decree, establishing the Second Regency of the Mexican Empire on the 11th of April 1822. The decree, signed by the Mexican politician José Luis de Quintanar (1772–1837) and effective immediately, names the members of the Second Regency, and asks them to go to the Congress Hall to take their oath. This transition set the stage for the president of the Regency, Agustín the Iturbide (1783–1824) to rise to power and become the first emperor of Mexico a few weeks later. Despite its importance, however, we have not been able to find other copies of the present decree in either sales records or any of the prominent Mexican pamphlet collections.

With two signatures at the bottom, a short printed text on the back, as well as a contemporary inscription (a summary of the decree in Spanish), and six tax stamps (two different ones from King Ferdinand VII of Spain, and one from the first Mexican Empire, all included twice). The edges are slightly frayed, the corners are slightly creased and stained, a horizontal and vertical fold line, with a small hole in the middle where they meet, affecting one letter. Otherwise in good condition.



This rare and important broadside is the first printed ceremonial protocol of independent Mexico for receiving a new government. Issued just months after the country's independence from Spain, it outlines in detail how the newly formed Regency was to be formally received by Congress, including the order of procession, a seating plan, the conduct expected of deputies, and the speech to be delivered by the president of Congress. The Regency was Mexico's first executive body that was not appointed by Spain, but by and for the Mexican people. The present broadside shows how the government's reception was meticulously planned and choreographed to highlight this shift in power.



Complete set of the second edition of a monumental bibliography concerning Spanish America, together with the first edition of the alphabetical index, making a total of 35 volumes. The main bibliography (excluding the index) was originally published in 7 volumes from 1923 to 1945 and revised for the present edition.

Another Addenda & corrigenda was published in 1990 and is not included the present set (as usual). In very good condition, wholly untrimmed and almost completely unopened.

Very rare first edition of the French translation of this important relation on Mexico by William Bullock (ca. 1773-1849), an English traveller, naturalist and antiquarian. He began as a jeweller and goldsmith in Sheffield, moved to Liverpool and brought together an interesting collection of natural history and art items. He founded a private museum in 1800 which he moved to London in 1810 and was housed in the newly built "Egyptian Hall". In 1822 and 1823, Bullock went by way of Jamaica to Mexico, being the first English traveller in Mexico since Thomas Gage (ca. 1603-1656) in 1640. Bullock visited many places and ancient monuments, of which extensive descriptions can be found in the present work. Attention is given to a wide range of subjects, including the history, geology, geography, flora and fauna of the country, and the culture, religion and commerce of its inhabitants. The volumes are uncut and partially unopened. The bindings show some minor signs of wear, the text volumes are somewhat foxed throughout. Otherwise in good condition.



Rare second issue of the first and only edition of a Dutch translation of *A concise history of the Spanish America* (1741), by the prolific Scottish author John Campbell (1708–1775). The work is divided into 4 parts, the first on the discovery of America, the second on the Spanish settlement in North America, the third a description of South America, and the fourth on the trade with America. The second and third part contain chapters on Buenos Aires, California, Charcas, Chile, Cuba, Florida, Guatemala, Lima, Mexico, Puerto Rico, Panama, Tucuman Province and Quito.

It contains 4 maps, not included in the original English editions.

With modern bookplate on pastedown and an earlier owner's name covered with opaque white. The sides of the binding were apparently never covered with paper, leaving the roughly cut ends of the sheepskin clearly visible. Binding slightly rubbed, lacking back endpapers and front flyleaf; title page loosening. Internally in very good condition.

Very rare publication written by the Cuban nobleman and military officer Antonio María de Cárdenas y Zayas-Bazán, 3rd Marquis of Cárdenas de Montehermoso (1778–1836), who was mayor of the town San Antonio de los Baños in Cuba. This letter, dated Madrid 24 June 1820 and signed "El Marques de Cardenas de Monte-Hermoso", is addressed to a high-ranking official or sovereign, referred to as "Señor". The text starts celebrating the restoration of the Spanish Constitution of 1812, originally promulgated in Cádiz. However, it also discusses grievances related to the representation of Spanish American provinces in the newly convened *Cortes* (Parliament). The author expresses concern about the unequal representation of Spanish American provinces in the *Cortes*, criticising the King's decision to appoint 30 substitute deputies for the overseas territories.

The document reflects the broader struggle for political representation and equality, both in Spain and its colonies, and underscores the complexities of governance during a period of significant political change.



Negotiation contract dated 1769, signed by the director Daniel Changuion and his commissioners Jan Wouter Valkenier and Cornelis Jacob van der Lyn, for an obligation of 1000 gulden for plantations in Rio Essequebo and Rio Demmerary. Essequebo, and Demerary which was part of Essequebo, was a Dutch colony from 1616 to 1814 and was part of the colonies which were also known as Dutch Guiana.

The whole financial system of these West-Indian obligations for the plantation owners was built on quicksand. Nevertheless, this obligation act reflects the optimistic zeitgeist of the 1769s, when the investments and obligations in the Dutch colonial plantations kept growing. Therefore this negotiation contract can be seen as an important document for the Dutch economical and colonial history.

With an owner's inscription in the right upper corner of the first page and a manuscript annotation on the last page: "Van 3. April 1793 betaald. 6 P. interest, in 10 Coup: af gegeven tot A[nno] 1803". Only with a few small tears on the former bindings places and on the outer edges of the folds. 

First and only edition of the German translation of *Voyage aux iles de Trinidad, de Tabago, de la Marguerite* ... (Paris, 1813). It was translated with additions by C.A.W. von Zimmerman. This is the only translation made after the French original. It was published as part of the series *Neue Bibl. D. wichtigsten Resebeschr.*, 5. The author, Jean-François Dauxion-Lavaysse (ca.1770-ca. 1830), describes at length the islands of Trinidad, Tobago, Isla de Margarita and the coast of Venezuela. In a manner between empirical observation and anecdotal accounts he touches on several aspects, such as natural history, geography, geology, socio-political structures and history. He had lived as a planter on Trinidad and drew from his experiences there. Also included is a part concerning the "negro race". The large folding map at the end shows the area between Isla de Margarita and Tobago, with details of the mouth of the Orinoco river in Venezuela.

Rare imperial decree issued during the final months of the First Mexican Empire as an attempt to deter political unrest. It was printed in response to a major rebellion which had taken place 19 days earlier in Veracruz to call for the end of Emperor Agustín's reign. The decree suspends regular legal protections for anyone suspected of conspiracy, rebellion, or threats to the Emperor or the state. Instead of going through normal courts, suspects were to be arrested on sight and tried by military tribunals. As Emperor Agustín I (1783–1824) abdicated less than three months later, the present decree offers insight into the ways in which he attempted to hold the Empire together in the face of open rebellion. With a contemporary annotation from February 1823 by Luis Antonio Garcia at the bottom of the final page. 

First edition of Dralsé de Grandpierre's imaginary voyages to Brazil, Argentina, Mexico, the Western African lands of Guinea, Ouidah (Benin), Martinique, Indonesia and Ile de la Pierre Blanche. The first part of the account presents a description of the voyage to Buenos Aires and Argentina. The second part is dedicated to his imprisonment by the English, during which he came to visit certain parts of Africa. After his liberation, he travelled back to Martinique. When the author arrived in Martinique he joined a group of buccaneers that brought him back to France.

From the renowned library of the English banker and bibliophile Henry Huth (1815–1878), with its bookplate on the front pastedown and a folding library description tipped in on the first free endpaper. In very good condition in a nice binding.





First edition of a magnificent show-piece displaying the recently discovered antiquities of Mexico, especially those of the Mayan city of Palenque, based on the expeditions of Captain Guillermo Dupaix in the years 1805 to 1807 and illustrated with 162 lithographic plates (including the frontispiece), mostly tinted or beautifully hand-coloured. Some copies were issued with the plates uncoloured and many with them partly coloured, but only a few with the splendid and extensive colouring shown here. The extraordinary illustrations, nearly all drawn by José Luciano Castañeda, who accompanied Dupaix on all three voyages, gave Europeans their first good look at Mayan civilization.





Rare printed circular documenting the first significant armed resistance to Emperor Agustín de Iturbide (1783–1824), the inaugural ruler of independent Mexico. The uprising occurred on September 26, 1822, in Nuevo Santander (present-day Tamaulipas), led by Colonel Felipe de la Garza (before 1798–1832), the region's most prominent military leader at the time. A month prior, Iturbide had ordered the arrest of 66 individuals accused of plotting against his regime. De la Garza was named among the conspirators, prompting authorities to dispatch a force to apprehend him. De la Garza, threatening to use force, demanded the release of the detained deputies, the relocation of Congress to a secure location, and that Iturbide honour his promises to respect the constitution. Lacking broader support beyond his province, De la Garza was eventually compelled to negotiate a surrender. He was taken to Mexico City, where Iturbide pardoned him and reinstated him to his former position in Nuevo Santander.

A formal appeal to the citizens of Mexico City for financial support in organizing the solemn oath of allegiance to Agustín de Iturbide (1783–1824), the first emperor of independent Mexico. The document is issued by the Constitutional city council of Mexico, which wanted the event to rival similar ceremonies held in the past, but did not have the funds to do so. It therefore turned to the city's wealthiest citizens to ask for a temporary loan, which would be reimbursed as soon as possible. With the present pamphlet, the council attempted to appeal to the citizens' sense of pride, patriotism, and community, framing the request as a civic duty. Anyone willing to participate was asked to sign the attached list. The members of the city council themselves had already contributed. The present work is signed by three of them in the hope to encourage others to follow their example.

With three contemporary signatures on the back (from Antonio Velasco de la Torre, Ignacio Paz de Tagle, and Dom Antonio García Illueca), a contemporary annotation on the second page in the margin ("doscientos pesos"), and a few corrections in the text. 



The West-Indische Paskaert engraved by Pieter Goos, in its rare first state, a nautical chart prepared for the Dutch West India Company (WIC) as an aid to crossing the Atlantic Ocean to the trading regions of the Americas and visiting trading posts in Africa. It shows parts of the east coast of North America, both coasts of South America, Mediterranean Europe and the west coast of Africa. Many West-Indische Paskaerten, as these navigational charts were called, were reprinted over and over from new states of the copperplates. For more than a century Dutch and foreign sea farers profited from their use on transatlantic journeys. The great cartographer Willem Jansz. Blaeu (1571–1638) published the first West-Indische Paskaert around 1630 using manuscript charts and other documents of the Atlantic and its coasts, including information provided by the Dutch WIC navigators who sailed these routes.





It was compiled by John Hay (1546–1607), who translated some of the items himself and added prefaces to some.

Included are some rare accounts written by Japanese Christians, such as Michael Chijiwa Seizayemon, Sanico Nobuaki, Protasius, the Daimyo of Omura, the Daimyo of Arima and others. There are several accounts by the Jesuit missionary Luís Frois, including an extensive letter on Japan and a letter from Nagasaki. Also included is a short general history of Japan. Rare first and only English edition of a pamphlet on the supposedly beneficial climate of the Isla de Pinos (now Isla de la Juventad) or Isle of Pines, an island south of Cuba. From the 1840s onwards, Dr. Hernández (1801–1890), a physician working and living on the island, had been promoting the healthful quality of the mineral waters of his hometown of Santa Fe, the island's capital. Furthermore, several experiments with patients had convinced him that the overall climate of the island was extremely salubrious. "Dr. Hernandez, especially refers to numerous cases as falling under his own immediate notice, in which tuberculosis of the lungs, scrofula, chronic inflammations, asthma, paralysis, ophtalmia, otitis, cystitis, epilepsy, and various nervous, uterine and cutaneous affections had been either very materially benefited or entirely cured by a prolonged residence upon the island, and a properly regulated use of its mineral waters, internally and externally" (BMJ).

When American (commercial) interest in the island rose in the early 20th century after Cuba's independence in 1898, Hernández's pamphlet was often cited in works promoting health tourism to the Isle of Pines. For general histories of the island, the pamphlet is of particular interest as it gives detailed information on the economy of the island – mostly agriculture and mining – in the 1850s.



The first edition of a learned essay in Latin on the origins of the American Indians. It culminated a fierce debate that began with Grotius in his 1642 Dissertatio de origine gentium Americanarum, which argued that the American Indians of North America descended from Norsemen crossed via Iceland and Greenland; those of the Yuccatan from Ethiopian Christians, also crossing the Atlantic; and the more "advanced" ones in Peru from Chinese who came by boat to the Pacific coast. Grotius based his theories partly on linguistic arguments, culture and artefacts, but also attempted to make the evidence fit the Biblical accounts of the world, and he supposed no people lived in the New World in pre-Christian times. Johannes de Laet published a sharp critique of Grotius's arguments in 1643, demolishing most of his edifice and suggesting numerous possible scenarios, particularly suggesting a much earlier (pre-Christian) migration from Scythia across a land bridge between America and Tartary. The two men continued an even more heated exchange. Grotius's death in 1645 gave the last word to De Laet, who nevertheless urged the young Hornius (1620-1670), to take the study further, leading to the present account.

The *Aperçu statistique* (pp. 221–300) deals with a large variety of subjects concerning Cuba, but is largely devoted to the production and trade of the island, comprising many tables and statistics. The supplement (pp. 301–326) contains a *Discours* by Ramon de la Sagra on Cuba's flora and agriculture. With this book Huber tries to show Cuba's prosperity, to attract new French investors to the island.

Kerret (1833–1898) sailed from Brest on 2 December 1852 as an official artist for the French Pacific squadron. When the Crimean War broke out, this squadron, then in Callao, was joined by a British fleet sent to neutralise the Russian navy in the northern Pacific Ocean. Together they sailed to the Marquesas, Honolulu and the Sandwich Islands before making a failed attempt to land at Petropavlovsk on the Kamchatka Peninsula.

The maps depict North and part of South America with the Caribbean, the islands of Martinique, Barbados, Santa Domingo, etc.

The author, a Dominican Priest, travelled to Martinique in 1694. He sojourned two years in the island and then sailed for Guadeloupe, where he was appointed procurator-general of the Dominican convents. He travelled extensively in the French, Dutch, and English Antilles, using his knowledge of engineering and agriculture to build water mills and dams, to dig canals, etc.





It was delivered by José María Bocanegra (1787–1862), a notable lawyer and politician, on January 10, 1823, during the public sessions of the National Institutional Junta. This Junta has been installed by the controversial Emperor Agustín I (1783–1824) after he had dissolved congress in November 1822. Bocanegra opposed the emperor and his actions. In the speech, he therefore presents the "Proyecto de Reglamento Político para el Imperio Mexicano", a political framework that aimed to define the political structure of the newly independent country. Bocanegra's vision significantly influenced the debates that eventually led to the drafting of Mexico's Constitution of 1824. 

He was the first to explore the vast territory of Guatemala, which was inhabited by the Itzas and the Locadons, describing his observations and experiences extensively. He starts describing his voyage from France to Central America and his first expeditions into the tropics, other chapters are devoted to Cuba, Havana and Isla de la Juventud (Isle of Pines), Guatemala, the indigenous populations, ancient ruins, forests, mountains and lagoons, and more geographical, ethnological and archaeological observations. In his report to the Paris Académie des Sciences of February 1850, Morelet indicated that he had deposited at the Museum 90 plants, 150 species of molluscs which were described for the first time, 32 unknown fish species, 104 reptiles, 70 birds and 57 mammals. 

First edition of the journal of the Dutch warship Spiegel, which served as the flagship of Michiel de Ruyter (1607-1676) during an expedition to the coast of Africa, the Caribbean and Newfoundland. At the head of a squadron of twelve ships, the Spiegel had officially been sent to the Mediterranean as a martial exercise against the Barbary pirates. However, its real destination was the coast of West Africa, where the Dutch West India Company (WIC) and the English Company of Royal Adventures were fighting to control the trade in gold and ivory. In an expedition that was secretly planned by anti-English members of the States General, De Ruyter was to recapture the lost African possessions. After a diversion along the Spanish coast, the Dutch set sail to Africa where, aided by local soldiers in service of the WIC, De Ruyter retook all lost possessions. For the next mission, he was ordered to recapture Nieuw-Nederland (the New Netherlands: parts of modern New York, New Jersey and Delaware), which had recently been captured by the English. With a description from a French-language bookseller's catalogue mounted on the inside of the cover. A good copy.

Beautiful watercolour drawing of a *Proboscidea louisianica* by the notable and versatile Dutch artist Aert Schouman (1710–1792). "He was best known for his ornithological studies rather than for his botanical work, but the latter are so pleasing, with the plants in their pale, scenic settings that do not distract the eye"(De Bray). This species, native to Mexico and the southern United States, is commonly known under a variety of names, including devil's claw and ram's horn. It's named after its claw-shaped seed pods, that appear as its fruit dries and the flesh falls away, leaving a hard beak that splits into two horns. Both the fruit and the seedpod are depicted.

Like most of Schouman's botanical drawings, the present is unsigned as it was probably part of the artist's private collection of study drawings auctioned after his death in The Hague on 10/11 December 1792. We like to thank the Schouman expert Charles Dumas for his information and confirmation of the attribution.

Very rare first and only edition of an illustrated description of 13 Jamaican plants (13 illustrated with 1 plate each, but only the first 9 described) by the Swedish botanist Olof Peter Swartz (1760–1818), who had drawn some 200 plants during his travels through the West Indies. 71 of these drawings were destroyed in WWII. J.F. Volkart made 13 engravings after some of these drawings for the present publication (all showing Jamaican plants): in the present copy they are delicately hand-coloured with a subtle gradiation of tones. It was intended as part of the first fascicule of a much larger publication that would have contained engravings after all of Swartz's drawings, but the rest still remains unpublished today. Swartz studied under Carl Linnaeus the younger and graduated with a doctoral thesis in 1781. From 1784 to 1786 he traveled via North America to Jamaica, Puerto Rico, Haiti and Cuba and made a special study of the flora of parts of Jamaica that western botanists had not yet visited.

# Important contribution to our knowledge of medicine on voyages to the Americas

First and only edition of a very scarce work on naval medicine. This practical handbook was written by doctors who served on Dutch war ships that sailed from the Netherlands to Curaçao. It includes numerous case studies of sick sailors on these ships during the 1740s, along with commentary from Abraham Titsingh (1684–1776), who was a surgeon to the admirality. The work is very rare, as it has only been recorded in four libraries, and we have only been able to find one other copy in sales records.

The numerous case studies presented in the work are incredibly detailed, and describe cases on board the ships *Middelburg, Maarssen, Tylingen, De Beschermer* and *Hartekamp*, primarily in the years 1743 to 1750, but with references to earlier voyages. They give a fascinating picture of illnesses and their treatment during voyages to the Americas. With the bookplate of Jan van der Hoeven mounted on the front pastedown. The wrappers are damaged around the spine with some loss of material around the joints, the edges of the wrappers are slightly frayed. The work is uncut, with a water stain in the head margin throughout, not affecting the text. Otherwise in good condition.

Large, very rare, hand-coloured copy of Willem Blaeu's famous wall map of the Americas, which is considered "one of the most influential maps of America ever made" (Burden). The map is based on the latest explorations and shows everything known at the time about the American continent, as well as the north and south pole, which are included on two inset maps. As the wall map was in great demand, but expensive and difficult to transport, it was also printed by various French and Italian publishers for the local market. Like Blaeu's edition, the French and Italian editions are very scarce, as it is highly unusual for wall maps from this period to survive. We have only been able to trace 4 other copies of the present edition in sales records of the past hundred years, of which only 1 is also hand-coloured.

The map is somewhat browned and stained, the surface has faded, the work has been professionally restored: it has been reinforced on the back, the colouring has been retouched, some of the losses have been filled in, the work has been toned and varnished. Otherwise in good condition.

First and only edition of a treatise on the American Aloe (Agave Americana), with a very rare additional plate not present in any other copies of the work. This plate, drawn by Busch (who we have not been able to identify) shows the spectacular blooming American aloe from the gardens of Köpenick Palace, which was the largest American aloe in any royal garden at the time. It caused a sensation when it finally bloomed in 1712 after 44 years; even Tsar Peter the Great paid a visit to admire it. The present plate is not only one of the few contemporary images of the so-called "wunderaloe" (miracle aloe), but also one of the very few illustrations of any part of the Köpenick Palace gardens of the time.

The wrappers are scuffed, the spine shows traces of use, with two small tears that extend into the front and back wrapper. The work is slightly browned throughout, with an additional plate not present in other copies. Otherwise in good condition.
